



On-site inspection for animal feed production facility in the country of the producer

Types of animal feed are required to inspect the animal feed production facility prior to importation

1. Especially controlled animal feed

- Types of Raw material

1. Meat meal
2. Degreasing meat meal
3. Meat and bone meal
4. Poultry meal
5. Feather meal
6. Poultry by-products meal

- Animal supplements : mineral supplements derived from animal bones.

- Category of pet food for dog and cat : Type of complementary Pet Food:

1. Products derived from parts of animal horns, ears, hides and skins, bones and hooves from cattle, sheep, goat, pig, deer and poultry that are not sterilized by passing them through a retort operation.
2. Munchy or Crunchy made from hides and skins of cattle, pig.

2. Animal feed derived from poultry

1. Poultry meal
2. Poultry by-products meal
3. Feather meal
4. Blood meal
5. Plasma powder
6. Poultry fats/oils
7. Egg powder
8. Palatability enhancers/Flavoring agent innards

3. Animal feed derived from cattle

1. Meat meal
2. Degreasing meat meal
3. Meat and bone meal
4. Bone meal
5. Greaves
6. Tallow
7. Plasma powder
8. Blood meal
9. Dicalcium phosphate
10. Gelatin and collagen prepared from bones
11. Tallow derivatives
12. Blood by-products
13. Products containing ingredients from cattle as listed in 1)-4) except those in the group of countries posing negligible BSE risk and there has been no case of Bovine Spongiform Encephalopathy (BSE).

Procedure for import of animal feed from exporting country

For the country that has never exported the animal feed derived from animal into the Kingdom of Thailand

1. The national veterinary authority (competent authority) of a country wishing to export animal feed into the Kingdom of Thailand shall submit a formal request to Department of Livestock Development (DLD).

2. The DLD committee and the responsible agency (AFVC) consider the information related to animal feed requesting for import according to the following procedure :

- 2.1 Carry out Fact finding mission and/or
- 2.2 Circulate related information to stakeholder and/or
- 2.3 Consult with relevant stakeholder through meeting and/or
- 2.4 Provide suggestion and advise through official DLD website

3. If information is completed in cause 2, DLD will officially inform the exporting country of the procedure for importation of animal feed into Thailand together with a questionnaire for risk assessment evaluation.

4. The exporting country shall submit the completed questionnaire to DLD with a list of animal feed production facilities wishing to export to Thailand to make an appointment for on-site inspection in the exporting country.

5. The DLD auditor team carries out an on-site inspection in the exporting country.

For the country that has previously exported into the Kingdom of Thailand

Establishment Audit

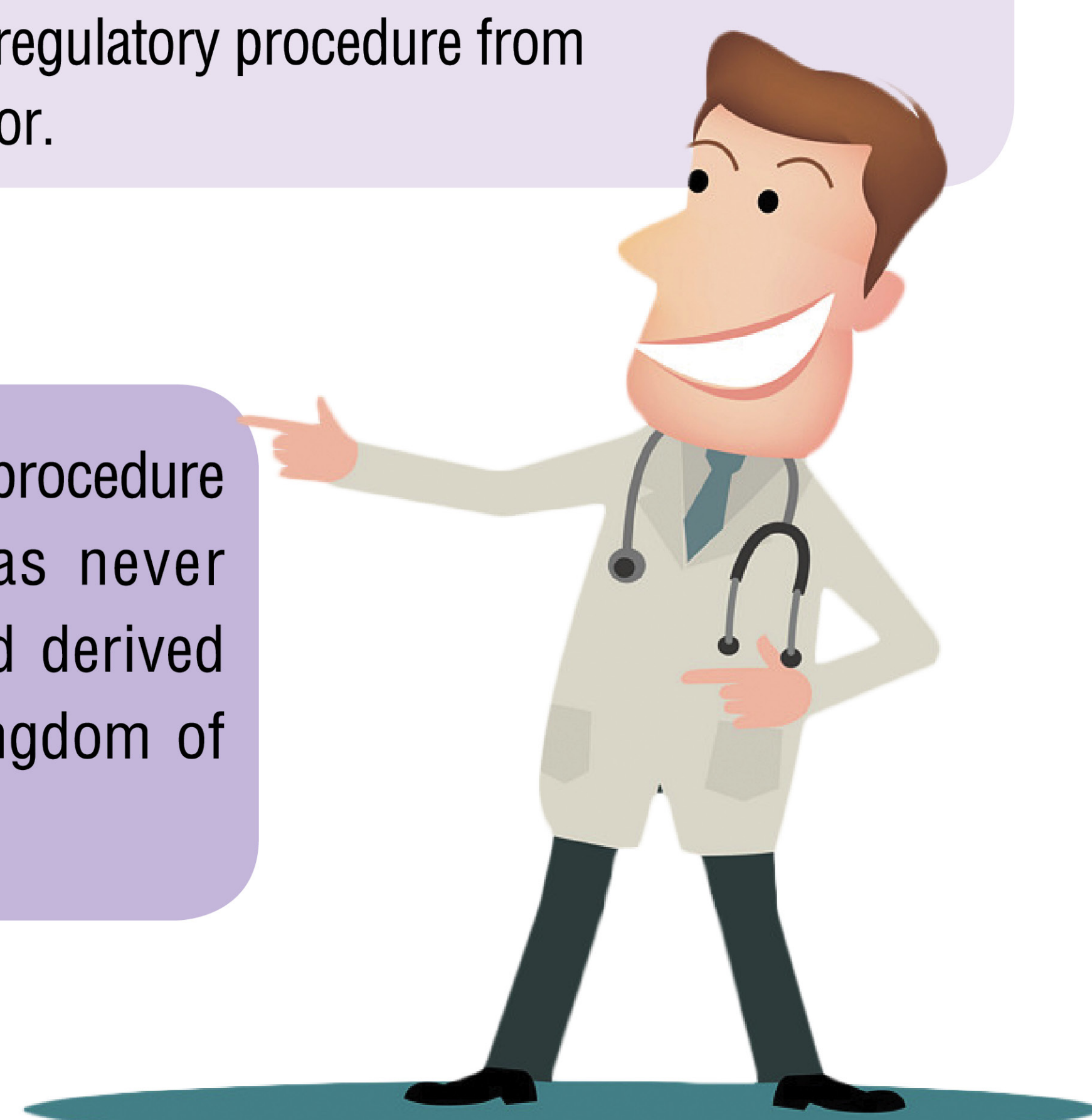
1. The national veterinary authority (competent authority) of a country wishing to export animal feed into the Kingdom of Thailand shall submit a formal request to the Department of Livestock Development (DLD).

2. The DLD officials will send the pre-on-site questionnaire to the exporting country, which should be completed and return to the DLD prior to an inspection.

3. The DLD auditor team carries out an on-site inspection in the exporting country. The on-site inspection will perform risk assessment and evaluate the production process and regulatory procedure from both official and private sector.

System Audit

The process will follow the procedure for the country that has never exported the animal feed derived from animal into the Kingdom of Thailand.

Note : Jorror.1 Application Form for on-site inspection of especially controlled animal feeds production facility that has never been inspected and certified by DLD.

Jorror.2 Application Form for on-site inspection of especially controlled animal feeds production facility with previous import history.

Jorpor.1 Application Form for on-site inspection of production facility of animal feeds derived from poultry or containing poultry ingredients or poultry products that are determined to have risk from avian influenza which has never been inspected and certified by DLD.

Jorpor.2 Application Form for on-site inspection of production facility of animal feeds derived from poultry or containing poultry ingredients or poultry products that are determined to have risk from avian influenza with previous import history.

Jorwor.1 Application Form for on-site inspection of production facility of animal feeds derived from cattle or containing cattle ingredients or cattle products that are determined to have risk from Bovine Spongiform Encephalopathy which has never been inspected and certified by DLD.

Jorwor.2 Application Form for on-site inspection of production facility of animal feeds derived from cattle or containing cattle ingredients or cattle products that are determined to have risk from Bovine Spongiform Encephalopathy with previous import history.
